# WHY?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this page carefully to understand what we do. The types of personal information we collect and share depend on the product or service you have with us.

WHAT? This information can include:

- Social Security Number and employment information
- Account balances, transaction history and credit information
- Assets and investment experience

# HOW?

All financial companies need to share customers' personal information to run their everyday business. Below, we list the reasons we can share a member's personal information; the reasons Empire One Federal Credit Union chooses to share; and whether you can limit this sharing.

Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial product or services to you.  • Our joint marketing partners include categories of companies such as insurance companies, auto dealers, auto makers, and membership clubs.
